DEADLINES APPROACHING

- The Indiana State USBC WBA Hall of Fame nomination forms must be postmarked by December 1 to be considered by this season's committee. If you have someone in your association that meets the criteria outlined in the nomination guidelines [described here](#), complete the form and please take the time to provide all of the necessary information. First, second, and third places are considered in state tournaments so be sure to include everything that is requested on the nominees form. The Hall of Fame Committee considers only the information that is submitted; they do not research the nominees. The Hall of Fame form can be downloaded from the [state website's](#) "Forms, References, Misc." tab, under Download Forms.
- Another deadline is that of our Indiana State Women's Championship Tournament, which is January 15. While it seems to be a while away, it will take time forming your teams, collecting information, and collecting fees from your bowlers. A [fillable form is online](#) so that you only have to fill in the information, print a copy for your records, and print a copy for you to mail with your fees. If it sounds easy, it's because it is!
